NARRATIVE:

Date 07-21-93 at 1030 hours I was contacted by phone by Sterling Van Wagenen. He said that he needed to report a case of a child abuse. He gave me the name of [REDACTED], [REDACTED] year old male, as the victim. He gave his name as Sterling Van Wagenen, he said that the was the perpetrator. I told Mr. Van Wagenen that if he needed to give me the information on this case that it would probably be best to meet with me at the police station, he agreed to do so. He said that he wanted to clear up this matter.

At 1300 hours Sterling Van Wagenen met with myself in the interview room at Salt Lake County Sheriff's Office, fifth floor Juvenile Division. The interview was tape recorded. Sterling states that in the early morning hours approximately 0130 or two o'clock in the morning of July 15, 1993, he had been awake [REDACTED]. He states that he has been treated by a David Hamlin*, [REDACTED] in Provo, Utah. The address of Mr. Hamlin is [REDACTED] Provo, Utah 84604, phone: [REDACTED]

Sterling states that he had walked downstairs into the family room. He said that his son [REDACTED] had a friend of his on a sleep over. This friend is [REDACTED]. Said that they were both sleeping on a couch. Said that he sat down and was watching the TV, said that he got up, went over and touched [REDACTED] on the abdomen. Said that he then touched [REDACTED] on the penis. Said that he did not attempt to masturbate [REDACTED]. Said that he touched him over his clothing and did not reach under at any time. He indicated that [REDACTED] woke up after approximately two minutes of this occurring.

Sterling described the touch on [REDACTED] as being more of a pat. Sterling said that [REDACTED] woke up. Said that he appeared to be somewhat in a daze, starred at the TV. He said that [REDACTED] then got up and went into the bathroom and locked himself in. Sterling said that he went to the bathroom door, told [REDACTED] that it would be okay, that he was going back upstairs and that he could do what he thought he needed to do.

Sterling states that he has talked to [REDACTED] parents, [REDACTED] and [REDACTED] and informed them of what has occurred. Said they also explained what had happened to his wife.
