Dear Mr. Eardley,

Your certified letter of February 10, 1976 was received a few days ago. We found it offensive, implying by the word "court" that we were to be judged. The phrase which you used, "summoned to appear", might better have been worded, "requested to appear" as we are no longer under your jurisdiction.

My wife, my daughter and I have already resigned from the L. D. S. Church by formal written notification addressed to the First Presidency on December 8, 1975.

The scientific world finds the Book of Abraham an insult to intelligence. Some of the most brilliant and qualified Egyptologists of our time have labled it fraudulent upon the overwhelming evidence of the recently discovered Metropolitan-Joseph Smith Papyri. No truly qualified Egyptologist has yet supported it.
